

## PUBLIC SECTOR TRANSFORMATION IMPLEMENTATION UNIT AT THE AUDITOR GENERAL'S DEPARTMENT

The Government of Jamaica has received funding from the World Bank towards the Strategic Public Sector Transformation Project and intends to apply a portion of the proceeds to fund project staff to support the Transformation Programme.

## The Government is committed to enhancing the efficiency, quality and cost effectiveness of public services.

The Auditor General's Department (AuGD) is tasked to audit annually, the appropriation accounts of Ministries, Departments and Agencies (MDAs). One hundred and sixty three (163) of these statements represent the financial statements of Statutory Bodies, Executive Agencies and Local Authorities in arrears for four or more years. The AuGD has embarked on implementing an Audit Outsourcing Project to eliminate the arrears over a two year period. In order to achieve this objective a Project Implementation Unit is to be established at the AuGD. To this end, the Ministry is seeking to secure the services of the following full time project staff:
